There are a few guidelines that I expect my clients to understand and follow for our relationship to work. ### Fees

Payment is expected at the time of the visit; clients will be charged a \$35 bounced check fee and all costs associated to acquiring payment.

### Procedure

We will spend time talking about what is going on with you spiritually, emotionally and energetically. Using my intuition, I will be looking at where in your body you are holding this energy so we can work through your trauma and/or blocks to allow you to manifest the life you deserve.

### Sessions

All sessions are held at **530 Blakslee Road, Dalton, New Hampshire.**

Most issues do not develop overnight; therefore, it is unrealistic to believe that one session will 'fix' everything. I recommend a series of consistent sessions to experience some, if any, relief. It is important to set aside any expectations regarding the results; your experiences will most likely be different each time you have a session.

### Appointment Policy

- ❖ Clients are expected to arrive for their sessions on time.
- ❖ Anyone under the influence of alcohol or drugs at the time of their session will be turned away and charged the full price for the appointment due prior to the next session.
- ❖ **A notice of 24 hours is required for canceling/rescheduling a session. You will be charged 50% of the session fee for late cancellations which will be due prior to rescheduling another appointment. I understand that unanticipated events and emergencies happen occasionally in everyone's life and this fee may be waived at Patricia Laurino's discretion.**
- ❖ Anyone who either forgets or consciously chooses to forgo their appointment for whatever reason will be charged a "no show" after 20 minutes and will be charged 50% of the session fee for your "missed" appointment. This amount must be paid prior to your next appointment.

If you arrive late, your session will be shortened to accommodate others whose appointments follow yours. Depending on how late you arrive, I may determine there is not enough time to start a session. Regardless of the length of the treatment given; you are responsible for the price of "full" session originally booked.
